# Filling Gaps for Greater Stability

Life can be especially difficult for some members of our community. Tight finances, health troubles, medical bills, and job difficulties place our neighbors in danger of losing their home. It could be working with a landlord to create a payment plan, finding short-term shelter with family or friends, or even connecting them to emergency financial resources. By helping people avoid the shelter system, it's easier for them to find their way back to full housing stability.





# Holistic Support, Every Day

No one should go through a crisis alone. Our Day Resource Center provides support to neighbors who are experiencing homelessness or a housing crisis. This point of entry is where they can have their most basic needs met to get out of homelessness and into housing, taking confident steps toward a better tomorrow.

# **CLIENT EXITS TO HOUSING**

A key measure of your impact is the number of clients finding safe, stable housing upon exiting our shelter system. Your support has provided even more secure housing for your neighbors this year as compared to last year. Exits to housing grew 3% over last year's exits to long-term housing–and that's even more impressive considering the ways COVID-19 affected our programming!

# **BETTER HEALTH & A NEW HOME**

Annie\* enjoys going to church, taking long walks, and visiting local parks. But she has faced serious troubles, starting with some serious health complications that made it increasingly difficult for Annie to work. Her financial situation grew worse without steady income, and then she had a property dispute with her landlord.

That's how Annie found herself facing homelessness. But Annie is hardly alone: the CDC reports that "homelessness is closely connected to declines in physical and mental health; homeless persons experience high rates of health problems." All this often leads to unexpected medical bills, difficulty working, and otherwise destabilizing health, security, and well-being.

Your gifts through PADS Lake County made it possible for Annie to take steps forward, starting with our Homeless Healthcare Access Program to improve her health.

From there, Annie successfully worked with one of our case managers to create and execute a housing plan. We're thrilled to share that Annie successfully moved into independent housing and is currently enjoying decorating her new space with antiques and flea market finds! Annie says, "I learned a lot about appreciating all the goodness PADS has to offer in their program. It is important to know there's a shelter. PADS is willing to help you out with anything you need help with, which was really nice."

### OUTREACH Meeting Neighbors Wherever They Are

Living on the street is its own kind of paralysis. It's hard to know where to go or who to turn to. So we take our services to our clients, wherever they may be: in a tent in the woods, warming up in the library, or seeking shelter in an abandoned building. Your gifts allow us to build relationships and trust with them so they can access the life-saving services they need to move out of homelessness and back into housing.

### SUPPORTIVE HOUSING Securing Homes to Halt Chronic Homelessness

Each person is a miracle and deserves to be treated with great care and dignity. That's why our model focuses on meeting basic needs first, before addressing the causes of homelessness. With your support, 25 individuals have a place to sleep, meals, and a sense of security through our Housing Support program. By working with a case manager, they are becoming more confident in their ability to live independently as they receive holistic care for physical, mental, and emotional needs.

### EMERGENCY OVERNIGHT SHELTER Always a Warm Welcome —

The northern Illinois winter is especially harsh for those experiencing homelessness. The overnight shelters you make possible ensure that everyone has a safe, warm place to sleep every night from October through April. Clients escape the cold in one site each night, usually at a local house of worship, where they enjoy camaraderie and receive dinner, breakfast, and a sack lunch. Beginning March 2020, as COVID spread, our shelter sites expanded into area hotels. Clients receive individual overnight accommodations to keep people healthy and safe.

Whether clients were sheltered at local houses of worship or hotels, they always found a safe, warm place to sleep and received basic needs assistance and supportive services. Your caring support this year has met the astounding 185% increase in need for emergency shelter.

Meet Judith

One of the most defining principles of our mission here at PADS Lake County is the care community members have for one another. We are a group of neighbors caring for and learning from our fellow neighbors. This mutual, reciprocal relationship becomes personal through our volunteer network. Volunteers invest their time and skills in a wide variety of ways, supporting clients physically, emotionally, and socially.

One unique offering is from volunteer Judith Joy, a mindset coach who led a workshop series for clients at PADS Lake County. "I help people feel better than they do now, explains Judith. "The better you feel, the more ease you'll have in your life. I've found that when we focus on what doesn't work or isn't working for us, the more things don't work. But looking for what does work, and focusing on that, helps us to make positive, lasting changes."

Workshop participants have been eager to learn how to adopt new perspectives and approaches to life. As Judith shared this framework from her own experiences, it created an open atmosphere where everyone could share and learn from each other. These connections produced true community for all.

#### **Volunteer Your Skills and Expertise**

If you are interested in contributing your unique skills and expertise, our volunteer opportunities will soon be back in motion. COVID-19 guidelines are currently limiting our volunteer interactions, but we would love to hear how you'd like to get involved! Judith has this encouragement: "It is worth it—everyone is so incredibly nice, both clients and staff. Those served at PADS are really eager to move forward." We're grateful for volunteers like Judith who make our community a great place to be!



Over the past five years, generous partners of PADS Lake County have spurred on significant growth to provide a safe, secure place for more people experiencing homelessness.


#### Annual Revenue by Year

Generous partners gave one-time gifts and multi-year commitments to ensure a safe, secure place for more people experiencing homelessness. Here's a snapshot of our income:


